Statewide Community Impact


2022 marked the first full year PennTAP had six regional technical advisors embedded in local communities across the state. As a result, our advisors played a larger role in strengthening bridges between Penn State Commonwealth campuses and their surrounding communities, supporting economic development, innovation, and sustainability projects alongside local and University partners.

As an example, one of our technical advisors connected Harmony Turbines, a company manufacturing residential wind turbines, to a faculty member at Penn State Berks with shared research interests. The new-found collaborators were able to submit a project proposal and received over \$69,000 through the Manufacturing PA Innovation Program.

On the other side of the state, two of our advisors worked alongside Penn State Shenango campus

representatives and local resource partners to support the Valley Shenango Economic Development Corporation's renovation of a former Westinghouse Electric Corporate site into an aquaponics facility. The advisors helped the organization pursue alternative energy sources, apply for federal grant funding, and tap into additional Penn State resources for workforce development, strategic planning, and design assistance.

With many similar community-oriented cases from the past year alone, our advisors continue to successfully weave together the key resources small to mid-sized business owners need across PA. Whether those resources be energy, university, grant funding, or innovation-related, our team combines its diverse areas of expertise to ultimately serve Penn State's land grant mission and play a big role in statewide economic development.

PennTAP believes in building up and supporting the next generation's workforce. In 2022, PennTAP not only connected small to mid-sized businesses with Penn State student talent through Learning Factory projects and capstone courses, but also directly provided on-site assessment and project experience to undergraduate and graduate students at Penn State. Over the course of 2022, PennTAP advisors mentored three graduate students who were able to complement their degrees with client-facing projects, including creating an action plan for small to medium-sized businesses to best approach Environmental, Social and Governance (ESG) considerations, designing the educational framework to help companies reduce energy usage, and reporting on PennTAP's positive economic and environmental impact.



In 2022, PennTAP helped businesses across the Commonwealth reduce operating costs by improving the energy efficiency of their buildings and assisting with grant applications to offset the cost of the upgrades.

PennTAP's first no-cost Department of Energy (DOE)sponsored PA Industry Energy Readiness Cohort came to a close in spring of 2022, with five different company site representatives completing training on DOE-developed resources that supports their organization as they pursue their energy management path.

JLG, one of the participating companies and a leading manufacturer of lift equipment, not only became a DOErecognized 50001 Ready certified company at the end of the program, but was also asked to present on a panel at the DOE Better Buildings, Better Plants Summit.

The technical assistance our advisors provide results in the reduction of energy use, water use, hazardous materials generation, and business costs. When clients implement PennTAP's sustainable and cost-effective strategies, the economy and overall sustainability of the surrounding community benefits. As a commonwealthwide service provider, PennTAP is committed to aligning with nine UN Sustainable Development Goals as well as the Penn State Strategic Plan for Ensuring a Sustainable Future.

In 2022, PennTAP played a key educational role in supporting the Local Climate Action Program,

a partnership initiative of the PA Department of Environmental Protection, Penn State's Sustainability Institute, and Penn State's Department of Energy and Mineral Engineering. The program is designed to train and assist local officials and community stakeholders on how to inventory and reduce greenhouse gas emissions through an engaged planning process facilitated by Penn State and other university faculty, staff, and students.

PennTAP advisors continue to engage with regional municipal partners to assist them in meeting their sustainability goals and requirements for the program.
